Persons taking up employment in Nigeria, and their spouses are to fill this form in duplicate. They are also required to submit their letters of employment, evidence of expatriate quota approvals, originals and two copies of each of all their credentials. For temporary work visas, prior approval from the Comptroller-General of Immigration Services in Nigeria is required.

All applicants should pay appropriate non-refundable visa fees into Leumi Bank account No. 221983/61 and attaché bank payment receipts to their applications before submitting at the visa counter.
